Incorporation of a subsidiary

Pursuant to Article 9.4.13 of the Charter of Central Express CVS JSC (the "Company") and having discussed the need to establish a wholly-owned subsidiary of the Company to manage current import and future export operations effectively, the undersigned, being all the directors of the Company, HEREBY RESOLVE AS FOLLOWS:

- 6. **THAT** Mr. Chinzorig Ganbold, Chief Executive Officer ("**CEO**") of the Company, be and is hereby authorized to verify the Charter of Central Commerce LLC on behalf of the Company;
- 7. **THAT** the CEO of the Company, be and is hereby authorized to put share capital and operational costs into Central Commerce LLC;
- 8. **THAT** the appointment of Mr. Chinzorig Ganbold (TZ86050612) for the position of CEO of Central Commerce LLC with effect from 21 February 2022 be and is hereby approved;
- 9. **THAT** the CEO of the Company be and is hereby authorized to open bank accounts on the name of Central Commerce LLC and appoint authorized signatories of such bank accounts; and
